OUR CAPITAL INVESTMENT FUND (CIF) IS A \$35.4 MILLION LENDING POOL MAKING FLEXIBLE CAPITAL AVAILABLE TO FINANCE LOCAL DEVELOPMENT PROJECTS. THE CIF WAS 96.7% DEPLOYED AT THE END OF 2023.
